BOURBON COUNTY, KENTUCKY IRELAND RECORDS

Will of a William Ireland mentions: No wife is mentioned. Children mentioned: John, James, William, David, and then apparently his sons-in-laws, Elijah Mitchell, John Adams and David Purviance.

Will of a William Ireland, not of record in Bourbon Co., Ky., who died Iredell Co., N.C.. But all of the above sons and sons-in-laws, were in Bourbon Co.,Ky. and all of them gave one Peter Fleming, Power of Attorney, to return to Iredell Co., N.C. and collect the legacy left them by William Ireland.

The date of the above instrument was Feb. 18, 1799, and is of record in Deed Book D, page 422, Bourbon Co., Ky.

Another record, not a will, but does name the heirs:

"James Ireland, William Ireland, David Ireland, James Alexander and his wife Margaret, late Margaret Ireland; Elijah Mitchell and his wife Sarah, late Sarah Ireland; David Purviance and his wife Mary, late Mary Ireland; John Adams and his wife Nancy Ireland; Peter Fleming, husband of the late Martha Ireland, deceased, and the following Flemings, children of Martha: John, Peter, Dr. J.P., Samuel, Andrew, Elijah and Martha Fleming, also David & Elizabeth Wasson, late Elizabeth Fleming; and all, the Irelands and Flemings, heirs of John Ireland, deceased; to Andrew Fleming, another of the Fleming heirs, Apr. 20, 1818. GALLIA COUNTY, OHIO IRELANDS

William Ireland, Jr. went to Ohio in 1811 and lived for a while in Gallia County. Was he related to ANN IRELAND b Mar- 17,1773, who m William Morrison and lived in Gallia County? William & Ann (Ireland) Morrison had daughter Mary Morrison b here Oct.16, 1802. Ann Ireland m William Morrison April 9, 1801 according to the family Bible, where is not known. She d Mar. 22, 1823, aged 50 years and 5 days.

Wm. Morrison was b Feb.1, 1763 and it is said he emigrated from Ireland, his home district being Colinsky Woods, in county Down, but nothing definite is known of him or his early life. Possibly ANN IRELAND came from the same area.
